Chairwoman Lena Charles opened the regular board meeting at 9:06 AM.

It was determined that a quorum was present and Chairwoman Lean Charles opened the meeting at 9:06 am.

Approval of March 25, 2022 Meeting Minutes: A motion to approve the March 25, 2022 meeting minutes was made by Sarah Branton and seconded by Don D'avy. Motion carried without objection.

ODDD Business of the Month Recognition 2022: On behalf of the board, Chairwoman Lena Charles recognized "Dupre Sebastian Fine Jewelry" that is located at, 822 South Main, Opelousas, LA as the April recipient for ODDD's Business of the month program. Mr. Robbie Sebastian, Owner, was present to accept the award.

*Financial Report:* Bill Rodier gave the financial report in the absence of Keith Broussard. Bill suggested that ODDD get a detailed ledger report from their accountant giving positive reasons for doing that. Lena Charles gave some updates about the TAP grant. A motion to accept the financial report was made by Pat Fontenot and seconded by Don D'avy. Motion carried without objection.

Executive Director's Report: Bill Rodier gave an update on the South Park project and reminded the board that interest on bonds are increasing. He reported about Retail Strategies' marketing analysis of the downtown area. He also reported on projects going that are beginning to move forward and the challenges going on with infrastructure. He encouraged the ODDD to be involved.

## New Business

*The Big Grant 2022:* The 2022 round of Big grants have been announced with a June 1, 2022, deadline. Sarah Branton reported that many businesses have shown interest. She expects to see many applicants however there are no active applications at this time.

Master Plan Review of Opelousas (Vacant structures and Maintenance Codes, CPEX, (GOAL 2022 #3): Bill Rodier gave a report on the circumstances getting the new businesses in the downtown. He explained the proposal from CPEX. Bill reported that he and Chairman Charles met with the CPEX team and reported that they (CPEX) will be coming to the board with a proposal soon. Bill expressed the need for an expert in this field and that he expects something from them at the next board meeting. Chairman Charles asked for a motion. A motion was made to engage CPEX to present a proposal to be reviewed by the City of Opelousas by Sarah Branton and Seconded by Rob Hilliard. The motion was carried without objection.

**Update on Billy's and Proposed Chick-fil-A Infrastructure:** Bill Rodier reported that an engineer from Chick-fil-A came to check on the infrastructure of the proposed property. He also explained that he had a meeting with city officials together with Chick-fil-A to discuss what must happen to make this deal work which includes the specific need of water and sewer to Chick-Fil-A. He explained a potential plan that would bring water and sewer for Chick-fil-A as well as future businesses. There will also need to be a solution for drainage. In addition, traffic will impact the area greatly and will require an additional turn lane. Bill also reported on Billy's Boudin's new location they are interested in building on and included that there has been interest from other businesses also considering moving into the area.

### **Old Business:**

ODDD Responses to SLED Board on CEA. Chairwoman Charles reported they are still working on the CEA and expects something soon.

The Walking Ladies Update for Phase II of permanent lighting: Chairwoman Charles reported that due to inflations Cynthia Lormand is still new getting quotes to continue the project.

City of Opelousas and ODDD projects, TAP grant scheduled for bid by June 8, 2022: Chairman Lena Charles informed the board that she received a call from David Jarrell and that they ensured her that they will make that bid date happen.

Grant submitted to Keep Louisiana Beautiful for Keep Opelousas Clean Project on April 21, 2022: Chairman Charles informed the board that the grant will be submitted today and publicly thanked Melanie LeBouef and Janece Riser for their collaboration and effort in getting this grant done.

New Life Center RFP Review Meeting scheduled for Monday, April 25, 2022, at 1 PM: Bill Rodier explained that there were only two proposals received. There are seven members on the committee that will meet and go through the process of considering the proposals.

- Small Business Summit, schedule April 27, 2022. ODDD Branding and Promotional Materials: Chairman Lena Charles reported about the summit and advised the board of the date and time and invited and encouraged them to attend. <u>Board Member Comments</u>
  - An active discussion ensued regarding upcoming projects, the issues surrounding the proposed Chik-fil-A property, and that the board wants to do everything they can to help make that happen.
