#### **Public Announcements:**

Daniel Lyons announced that the grants/financial assistance given for the horse/track facilities will be available soon.

Wil Fontenot advised about the Opelousas Safe Love Project's Opelousas Love Fest that's going to be happening on September 5, 2021, from 9am-7pm. This Project is focusing on things like breaking down barriers and creating trust with City Officials. Financial contributions are being solicited and there is a planning meeting that will be held at the Delta Grand on July 27, 2021, at 3pm.

#### New Business:

**Property Appraisal:** Bill Rodier gave an update on the received appraisal for the agricultural property next the distribution center that has been received by Southern Skies Appraisal. Mr. Rodier reminded the board that the Ag lease for that property was not renewed so he advised to keep in mind the longer the property sits, the greater chances we may have to do some maintenance that the farming tenant had done previously. Ken Simeral advised that property usually is not purchased or sold depending on things like road maintenance so that does not need to be included in this discussion. He also gave some other points in reference to marketing and selling property. After a brief discussion, it was decided to list the property with a realtor/broker to get the property marketed. A motion to allow board to market the property was made by Don Reber and seconded by Seth Robin. Motion carried without objection.

*Midway Corridor Phase II:* Bill Rodier gave an update on Midway Corridor Phase II. A motion to allow Chairman Dakin to sign on behalf of the board was made by Lena Charles and seconded by Wil Fontenot. Motion carried without objection.
