It was determined a quorum was present.

A representative from the Clerk of Courts was not present to swear in the new board members so Chairman Dakin decided to continue with the agenda until a representative showed up.

*Meeting Minutes:* A motion was made by Don Reber to accept the December 2021 board meeting minutes and seconded by Roma Stewart. Motion carried without objection.

**Financial Report:** Hals Beard provided an overview of the December 2021 financials. Bill Rodier clarified some key information regarding the revenue and expenses. A motion to adopt the December 2021 financials was made by Erika Milton and seconded by Don Dejean. Motion carried without objection.

### Old Business:

Walmart PILOT Agreement: Bill Rodier gave an introduction on the Walmart Pilot agreement. Eric LaFleur gave an update on the status of the agreement. He explained the amount paid to SLED is going to be a percentage paid by each district totaling the current amount. There was an in-depth discussion where he answered several questions from the board of commissioners. The next step of this process is for SLED to have a CEAs with the parish signed. A motion by Seth Robin and seconded by Roma Stewart to approve the CEA. Motion carried without objection.

*I-49 Midway Corridor Activity Update:* Rachel Goudeau gave an update on the growth and development in preserving the exchanges and frontage roads in St. Landry Parish. She stated the project is still on track with the performance land implementation that is being modeled after the one Carencro has in place. Cade Jones gave an introduction of himself as the newest part of the One Acadiana team on this project. Bill Rodier stated that everyone will be invited to the meetings so that everyone will be well versed and know the main talking points.

Organizational Staffing Structure: Bill Rodier updated the board with the process of hiring for the Administrative Assistant position as well as the Project Coordinator position. The hiring committee has begun interviewing. The project coordinator interviews are complete and there's one more interview for the Admin Assistant position. After the committee concludes the interviews, Bill Rodier will interview each candidate.

### New Business:

Election of Officers – A motion to allow the current officers to remain in their position was made by Lena Charles and seconded by Don Reber. Motion carried without objection. 2022 SLED Officers are as follows:

Committee Appointments – Chairman Dakin clarified the executive committee consists of the board officers along with additional 3 board members.

Everyone nominated accepted their nomination. Andy Dakin explained the voting process. The outcome of the election reveals that Erika Milton, Seth Robin, and Lena Charles are the final members of the executive committee.

Real Estate Committee – Andy Dakin advised that the real estate committee consists of Don Dejean who is also the board's vice chair as the Chair, Ken Simeral, Seth Robin, Wil Fontenot, and Don Reber. There is a 6<sup>th</sup> position available so if anyone wishes to sit on the board, he asks that they get with him after the meeting. All current members expressed wishes to remain on the board.

Presentation: Patrick Jenkins with the St. Landry Parish School Board - Bill Rodier introduced Dr. Patrick Jenkins. Dr. Jenkins gave a presentation of the upcoming Superintendent Patrick Jenkins gave a presentation on the 2022 St. Landry Parish School Board Bond Initiative that will be addressed in the March 26<sup>th</sup> election. He stressed the point that although both bonds are needed, the bonds are not tied together so they can be voted on individually. The board was given the opportunity to ask questions and get clarifications.
