Meeting Minutes:

A motion was made by Don Reber and seconded by Roma Stewart to accept the April 2022 board meeting minutes. Motion carried without objection.

Financial Report:

Hals Beard provided an overview of the April 2022 financials. A motion to adopt the April 2022 financials was made by Ericka Milton and seconded by Seth Robin. Motion carried without objection.

Hals Beard provided an overview of the May 2022 financials which included a \$2,500 donation from SLEMCO for economic development. A motion to adopt the May 2022 financials was made by Sharon Ortego and seconded by Don Reber. Motion carried without objection.

Amend Operating budget of Revenue and Expenditures for the Fiscal Year Beginning July 1, 2021, and ending June 30, 2022: Dana Quebedeaux gave an overview of the amendment of the Operating budget of Revenue and Expenditures for the Fiscal Year Beginning July 1, 2021 and ending June 30, 2022. A motion to adopt the amended budget was made by Boisy Pitre and seconded by Don Reber. Motion carried without objection.

Adopt the Operating Budget of Revenues and Expenditures for the Fiscal Year Beginning July 1, 2022, and ending June 30,2023: Dana Quebedeaux gave an overview of the proposed Operating budget of Revenue and Expenditures for the Fiscal Year Beginning July 1, 2022 and ending June 30, 2023. Legislative Session Update: Keely McGibboney with One Acadiana gave a recap of the 2022 Louisiana Legislative session focusing on infrastructure, education, and business-related progress in the session. She also discussed several amendments that will appear on the statewide November 8th ballot.
