**CERTIFICATION OF INABILITY TO OPERATE DUE TO LACK OF QUORUM**


In accordance with R.S. 42:17.1 this notice shall serve as certification of the Opelousas Downtown Development District's inability to otherwise operate in accordance with the Louisiana Open Meetings Law due to such a meeting being detrimental to the health, safety, and/or welfare of the public as a result of the public health emergency, as declared by Governor John Bel Edwards on March 11, 2020 by JBE 2020-25.

The Opelousas Downtown Development District will provide for attendance at its essential government meeting on Tuesday, April 13, 2021, via zoom conference because it is unable to obtain a quorum. It is essential that the Opelousas Downtown Development District continue to operate in order to consider matters that are critical or time-sensitive and in the determination of the presiding officer should not be delayed; however, such matters shall not be considered at the meeting unless the members of the body present at the meeting approve the consideration of the matters by a two-thirds vote.

Considering the foregoing, and in accordance with R.S. 42:17.1 and Governor John Bel Edwards's executive orders, the Opelousas Downtown Development District meeting on Tuesday, April 13, 2021, at 12:00 pm will be held via zoom conference and in a manner that will allow for observation and input by members of the public, as set forth in the notice posted on April 12, 2021.

All comments from members of the public are limited to five minutes when read aloud. All public comments will be properly identified and acknowledged during the meeting.
